Secretary Elaine L. Chao is currently the U.S. Secretary of Transportation. History already knows her as the former U.S. Secretary of Labor—the first Asian American woman in our country’s history to be appointed to the President’s cabinet.

Secretary Chao has a distinguished career in the private, public and nonprofit sectors. She was a transportation banker in the private sector, and worked on transportation issues at the White House. She then served as Deputy Maritime Administrator; Chairman of the Federal Maritime Commission; and, Deputy U.S. Secretary of Transportation. She also served as Director of the Peace Corps, and President and CEO of the United Way of America.

Secretary Chao is a strong advocate for safety, and the importance of infrastructure and innovation in our nation’s economic competitiveness and economic growth. As Secretary of Labor, she focused on increasing the competitiveness of America’s workforce in a global economy, promoted job creation, and achieved record results in workplace safety and health.

Secretary Chao earned her MBA from the Harvard Business School, and is the recipient of 37 honorary doctorate degrees. She is the eldest of six daughters. Now a resident of Kentucky, she grew up in Queens, New York and often led her younger sisters on the bus and subway systems of New York City (MTA). She is very familiar with the mass transit systems of every city she has ever lived in.

Honoring Our 2019 Accomplishments





*W*elcome to the 2020 Federal Transit Administration Awards Program! It's an honor and privilege for me to continue to serve as the Acting Administrator of FTA under the leadership of Secretary Elaine L. Chao. FTA's success in achieving our mission to improve public transportation for America's communities is possible because of the dedication and commitment of each and every one of you. Your knowledge and passion for public transportation is evident in everything you do. I am extremely proud of the work we do to promote safety, invest in transit infrastructure and drive innovation.

Safety is Secretary Chao's number one priority. Building on the successful establishment of State Safety Oversight programs, we now turn our focus to complying with the Public Transportation Agency Safety Plan (PTASP) regulation. Since FTA issued the PTASP regulation in July 2018, we have engaged in a robust technical assistance campaign to support transit agencies and States in developing Agency Safety Plans and meet the July 20, 2020 compliance deadline. We have supported the industry's on-time compliance through a comprehensive outreach program with interactive training workshops, webinars, conference presentations, articles, webpages and establishing the PTASP Technical Assistance Center.

In 2019, FTA awarded more than \$15 billion to support transit agencies and state DOT's through both formula and competitive programs including investments in bus fleet modernization, state of good repair needs and planning for Transit-Oriented Development. In addition to these programs, FTA's new Helping Obtain Prosperity for Everyone (HOPE) program will support planning, engineering and technical studies or financial planning to improve transit services in opportunity zones or areas experiencing long-term economic distress. I am proud of our focused approach to increasing rural participation in support of the Department's new Rural Opportunities to Use Transportation for Economic Success (ROUTES) initiative which seeks to address disparities in rural transportation infrastructure.

FTA is driving innovation in the transit industry through its Accelerating Innovative Mobility (AIM) initiative and Integrated Mobility Innovation (IMI) Program. With AIM, FTA is driving innovation across the transit industry by promoting forward-thinking approaches to improve financing, system design and service. The IMI program supports projects using innovative technologies to improve transit access, increase efficiency and enhance the rider experience. Thank you to all of you who work to manage these new programs as well as all of our competitive grant programs.

Today's ceremony is a way to show our gratitude and appreciation to our colleagues for their individual and collective contributions to FTA's success and to thank each of you for your role in making America's transportation network safe and reliable. Congratulations to all FTA award recipients! I am excited to recognize you for your outstanding work and have the opportunity to thank you personally on behalf of Secretary Chao for a job well done.

Award Categories

Administrator's Superior Achievement Award

The highest award granted by the FTA Administrator for exemplary achievements that contributed to the accomplishment of the agency's or the Department's mission or programs. The results and manner of performance clearly reflect Agency goals and serve as a model to other FTA employees.

Administrator's Award of Merit

The second highest award granted by the FTA Administrator that recognizes exceptional achievements which contributed to the accomplishment of DOT's or FTA's mission or programs. The results and manner of performance clearly reflect Agency goals and serve as a model to other FTA employees.

Excellence in Mission Results Award

This award is granted to any FTA employee whose demonstrated dedication and whose special efforts made significant contributions to FTA's strategic plan goals, mission objectives, and/or major programs.

Ann Linnertz Award For Mission Support

This award is granted to employees at any grade level and occupation who demonstrate a sustained commitment beyond normal expectations to support the accomplishments of their office's and FTA's mission or program activities, a strong and consistent work ethic, expertise, professionalism, and reliability which are essential to the smooth operation and success of the organization.

Excellence In Management Award

This award is granted for exemplary supervisory contributions in achieving FTA's mission and goals and management of human resources that are worthy of special recognition.

Excellence In Leadership Award

This award recognizes sustained contributions based on an individual's effectiveness as a leader – either supervisory or nonsupervisory, the productivity of the individual's program or demonstrated ability to develop the administrative or technical talents of other employees.

Business Process Improvement Award

This award recognizes individuals, groups, or parts of organizations that can be held up as models for others because they have implemented business practice changes which improved performance or resulted in strategic planning; a focus on business partners, customers, and stakeholders; or improving processes.

Humanitarian Honor Award

This award will be presented to FTA employees who have displayed courage or exceptional personal responsibility either on or off the job that had a major impact on someone's life. However, these acts should be ones that are not considered to be part of a person's job. This award is designed to give FTA employees an opportunity to publicly recognize a colleague for being exemplary when it comes to helping others in unusual or emergency circumstances.

FTA Team Award

This award is designed to recognize groups and teams both internal and those that cross organizational lines for exceptional performance that supports the improvement, reinvention, or reengineering of practices, operations, and customer services and/or emphasizes cooperation, collaboration, and integration.

Regional Team Excellence In Project/ Program Delivery Award

This is a prestigious award designed to recognize regional groups or teams for exceptional performance that supports transit oriented grant programs and reviews, project delivery, and the improvement, reinvention, or reengineering of practices, operations, and customer services.

Associate Administrator's/ Regional Administrator's Honor

This award is designed to give our Executive Management Team Members an opportunity to select an individual or team that has accomplished exceptional achievements within their Office.
