SUMMARY OF GRANT AND OTHER ACTIVITIES OF THE URBAN MASS TRANSPORTATION ADMINISTRATION

During October 1976 the U.S. Department of Transportation's Urban Mass Transportation Administration (UMTA) announced the award of 78 grants totaling \$453,839,375.

A digest of the announced grants including a short description of capital improvement and research projects, their dollar amount, UMTA project number and date of announcement follows. Transit planning (technical studies), Section 5 apportioned funds for operating assistance), managerial training and university research and training grants are so noted.

- O An announced decision by the Administrator to provide funds for engineering and environmental analysis for a first stage major upgrading of existing trolley service in the South Hills area of Pittsburgh, Pennsylvania.
- O Publication of a compilation of 136 urbanized areas by States to show the address of a person responsible for public transit in that locality.
