SUMMARY OF GRANT AND OTHER ACTIVITIES OF THE URBAN MASS TRANSPORTATION ADMINISTRATION

During November 1976 the U.S. Department of Transportation's Urban Mass Transportation Administration (UMTA) announced the award of 47 grants totaling \$25,233,017.

A digest of the announced grants including a short description of capital improvement and research projects, their dollar amount, UMTA project number and date of announcement follows. Transit planning (technical studies), Section 5 apportioned funds for operating assistance, managerial training and university research and training grants are so noted.
