ATM Pledge System Provides Assistance To Beneficiaries Of Deceased Members

A unique "insurance" project is the Air Traffic Management pledge system started in 1949 in an effort to provide assistance for beneficiaries of deceased members. This plan stipulates that each member of the pledge system contribute \$5 upon notification that a member of the system has died.

Each ATM facility has a designated representative who keeps a list of pledge members, their numbers and current beneficiary and address.

The amount forwarded to the first

The Regional office keeps a list of pledge system members by name and will depend upon facility representatives to advise of the death of any of their members, together with the latest and correct information on the beneficiary name, address and relationship to the deceased.

Upon receipt of this information, the regional office issues a message to all regional facilities advising them of the death and the name and address of beneficiaries.

The regional office compiles all figures and notifies the field of the total amount forwarded to the beneficary. The regional office also asks beneficiaries to compile a list of all contributions received from the facilities and send this information so that a double check can be made.

Facility representatives also advise the Regional Office of any change of official station, transfer out of the Region, new members, cancellation of members, resignations and retirements.

In the case of **change** of official station, the facility representatives forward pledge forms of a member to his **new** facility.

If a member transfers out of the region, retires or does not contribute upon the death of another member, he is automatically dropped from membership and the facility representative advises the regional office.

Accordingly, the total amount of contributions forwarded to the beneficary of the latest member to succumb was \$11,455.

Since its inception in early 1949, a total of 36 members have passed away.

The amount forwarded to the first beneficiary in 1949 was \$1,285 as opposed to the aforementioned latest sum forwarded.

ATM personnel who have been members of the pledge system since its inception have paid out \$180 each over the past 10 years. This averages out to approximately \$8 per member per year.

As a testimonial to the sympathetic help provided by the pledge system, ATM is prideful of its part in generating the sentiments so well expressed by the following letter from Mrs. Philip Lyng of Hanover, N.H., to Chief, Wayne Hendershot:




