SECRETARY CARD ANNOUNCES INTENT TO AWARD \$416.5 MILLION IN FEDERAL TRANSIT GRANTS

Secretary of Transportation Andrew H. Card Jr. today announced that the Federal Transit Administration (FTA) intends to award \$416,474,643 for 218 projects, including the first grants made under the flexibility provisions of the Intermodal Surface Transportation Efficiency Act (ISTEA).

"These grants will bolster the economy by supporting new and existing jobs across the nation while also improving mobility and reducing congestion," said Card. "Four of the projects represent the first opportunity for communities to use federal funds for either transit or highways, basing the decision on local needs rather than federal fiat."

The four projects and amounts of flexible funds used include: Greater Hartford (Conn.) Transit District, \$61,832; Chittenden County Transportation Authority in Burlington, Vt., \$190,000; Omaha (Neb.) Metro Area Transit, \$400,000; and Baltimore State Railroad Administration, \$3,300,000.

Under another ISTEA provision, metropolitan and state FTA planning grants are now made as a unified grant to each state. Approximately 350 annual individual federal grant actions have been reduced to 52 annual grants.

Secretary Card said, "This restructuring will make it possible to provide more federal money, put it to work faster and improve transit in our cities."

The largest award is a grant of \$60.9 million to California.
