DOT ANNOUNCES SERIES OF HEARINGS ON AMERICANS WITH DISABILITIES ACT

The Department of Transportation has announced a series of six public hearings to solicit comments on DOT's proposed rule governing transportation for individuals with disabilities.

The new rule was proposed as part of the implementation of the Americans with Disabilities Act of 1990 (ADA). Each of the hearings, which will be conducted by the department's Urban Mass Transportation Administration (UMTA), will take place in a different city between April 23 and May 9.

"These hearings are a vital step in our efforts to implement the ADA," said UMTA Administrator Brian W. Clymer. "Making the benefits of transportation available to all Americans, including disabled citizens, is a major objective of the Administration's National Transportation Policy. Indeed, the agency is committed to working with transportation providers to increase access and mobility for the disabled."

The proposed rule includes new sections on the definition of comparable paratransit service and on criteria for transit operators to request and receive an "undue financial burden" waiver from providing comparable paratransit service. Paratransit service includes alternative forms of public transportation, such as door-to-door van service.

"The hearings are designed to give all interested individuals a chance to help us shape the rule. All statements and materials received at the hearings will become part of the official rulemaking docket," Clymer said. "Written statements mailed to UMTA will also become part of the docket."

Sign and oral interpretation will be available at each hearing, as well as an assistive listening device.
