UMTA ANNOUNCES \$895 MILLION IN MASS TRANSIT ASSISTANCE

The Urban Mass Transportation Administration (UMTA) has awarded approximately \$895 million in federal transit grants for projects in 42 states, Administrator Alfred A. DelliBovi announced today.

DelliBovi said, "This total for the second quarter of Fiscal Year 1988 is the largest of any single quarter since the streamlined grants release process was implemented in 1985." UMTA uses a special grants management system to expedite actual delivery of funds to transit agencies, thus ensuring a predictable flow of funding to recipients.

With approval of the 151 grants in this cycle, UMTA will have obligated more than 50 percent of the funding available in FY 88 from the programs which apportion funds according to a formula prescribed by law. "This obligation rate is a significant improvement over previous years," DelliBovi said.

The grants awarded will fund a variety of transit projects, including the purchase of buses, maintenance and support facilities, bus passenger shelters and bus stop signs, as well as improvements in communications and computer equipment.
