UMTA AWARDS 18 UNIVERSITY RESEARCH GRANTS

Secretary of Transportation Elizabeth Hanford Dole, today announced the award of \$1.3 million in Urban Mass Transportation Administration (UMTA) federal research grants to 18 Universities to study transit issues.

Secretary Dole said, "This Administration is committed to providing the best transportation services at the least cost to the taxpayers and the consumers. The focus of these studies include safety, drug and alcohol related issues, the role of the private sector in providing mass transportation services, rural transportation services, performance, new technology in bus maintenance and automation."

Ralph L. Stanley, UMTA Administrator said, "This program is particularly valuable because it encourages new ideas and moves them from the drawing boards and planning departments into revenue service. These studies will assure that transportation will enjoy a safe and healthy future."
