UMTA ANNOUNCES APPORTIONMENTS FOR FY 1987

Ralph L. Stanley, Administrator of the Urban Mass Transportation Administration (UMTA), has announced the apportionment of more than \$2 billion in Federal funds for transportation assistance in Fiscal Year 1987 for urban and rural areas.

Included in the UMTA apportionments are:

A total of \$1.9 billion for urban formula grants to provide capital and operating assistance. Areas with more than 200,000 in population are apportioned these funds directly based on population, density and the area's transit service. For areas between 50,000 and 200,000 state governors receive the apportionment for allocation within the state. The apportionment of these funds is based on population and density.

UMTA apportioned \$75 million for obligation by state governors in rural areas for capital and operating assistance. These apportionments are also based on population.

A complete listing of the apportionments according to state, locality and amount will be published in the Federal Register on December 17, 1986.
