DOLE ANNOUNCES
TRANSIT ASSISTANCE GRANTS

Secretary of Transportation Elizabeth Hanford Dole has announced the approval of Urban Mass Transportation Administration (UMTA) transit assistance grants totaling approximately \$674 million.

The grants will provide capital, planning and operating funds for public transit activities nationwide and in three territories. They will also provide funds for public transportation projects in non-urbanized areas and for transportation assistance for elderly and handicapped persons.

In making the announcement Secretary Dole said, "Transportation plays a major role in our economy and in our businesses. Six million people ride to and from work each day on mass transit. The Reagan Administration is continuing its commitment to sound, cost effective transportation services to meet transportation needs."

UMTA Administrator Ralph L. Stanley added these grants are released through a quarterly review process established by UMTA this year. Applicants who submit complete applications which meet minimum statutory requirements receive their funds within 90 days. Also announced are grants to states and planning agencies which are released every 60 days.

Stanley said the reception to the process has been excellent. "Grants that used to take three to four months to process are now completed within a few weeks. We have eliminated a lot of bureaucratic red tape and dramatically cut the amount of time it takes to process a grant."

Formula grants totaling approximately \$598 million will go to transit authorities throughout the country to fund capital, planning and operating projects. These grants are a primary source of Federal funding for most transit authorities.

In addition, 24 states will receive over \$50 million for public transportation projects in rural and small urban areas. The funds can be used for capital, administrative, planning and operating assistance and are matched by state and local funds.

A total of approximately \$15 million will be distributed to 26 states to assist private nonprofit organizations which provide transportation services to elderly and handicapped persons.

States and metropolitan area planning organizations will receive about \$10 million under UMTA's technical assistance programs.
