UMTA AWARDS 15 UNIVERSITY RESEARCH GRANTS

The Urban Mass Transportation Administration (UMTA) announced today that a total of \$966,453 in federal research grants has been awarded to 15 universities to study transit issues.

UMTA Administrator Ralph L. Stanley said, "Transit service must provide the best service for the least cost. Four of the projects will investigate the role of the private sector in providing mass transportation services. Others cover a broad spectrum of transit concerns, including rural transportation, monopoly, deregulation, population trends and productivity."
