FEDERAL HIGHWAY ADMINISTRATION BEGINS MOVE TO THE NEW DOT HEADQUARTERS BUILDING

During the week-end of October 10, approximately 240 FHWA employees were moved to the third floor of the new DOT Headquarters Building. Another 300 employees of FHWA are scheduled to be moved over the week-end of October 17. Each week-end thereafter will increase the building's population.

OST ACCOUNTING OPERATIONS DIVISION IS IN ITS NEW QUARTERS. All accounting mail and documents from OST, FRA, UMTA, and NTSB, formerly sent to accounting operations in the Donohoe, Coast Guard, Temporary E, and HUD buildings, should now be routed to the new location: Accounting Operations Division, TAD-45, Room 2228, DOT Headquarters Building. Further details regarding this specific change are given in DOT Notice 1700.14.

REVISED OCCUPANCY SCHEDULE. Revision of 5th floor space planning in the new building requires a reversal of 6th and 5th floor occupancy dates; this means the 6th floor should be ready November 7 and the 5th floor on November 21.

QUESTIONS ON PARKING

- 1. What are the criteria for parking privilege?
- A. These have not as yet been completed; an order is in preparation and will be coordinated with the administrations and NTSB soon.
- 2. Will PMI have any right to revoke a permit in Nassif Bldg.?, in FOB-10A? Under what conditions? How?
- A. No. Parking permits will be controlled by DOT. Any problems will be resolved in accordance with DOT procedures.
- 3. When will the Nassif Bldg. garage be opened for \$35 parking? What related publicity is planned and when will it be released?
- A. Parking at \$2 a day or \$35 a month through December 31, is available now. A PMI representative is located in Room 2316 in the Nassif Bldg., ext. 23811. Those employees wanting temporary parking through December 31, should make arrangements through this representative. This was mentioned in our last Bulletin.
- 4. Will any arrangements be made by PMI in FOB-10A similar to that planned in Matomic Bldg. and Nassif for accepting applications and checks for \$35 parking from 10A employees or will they have to go to Nassif or the PMI downtown office?
- A. FAA employees wanting temporary parking through December 31 should apply at the Nassif location.



- 5. Will DOT be guaranteeing PMI a set minimum income when the equalized rates go into effect? i.e., if some of the spaces allocated for DOT employee parking go unutilized, what are the "contractual" consequences?
- A. There is no guaranteed minimum income. PMI will be paid a set rate for only those spaces used.
- 6. Will there be a carpool locator board in the Nassif Building?
- A. As mentioned in Bulletin #2, there are plans for such a board to be located most likely in the second level garage area. Details will be issued when available.
- 7. What arrangements will be made for visitor parking?
- A. Hourly and daily parking will be available at commercial rates for nongovernment vehicles. Arrangements will be made to accommodate 'government vehicles in the government parking area.
- 8. What arrangements can be made for temporary parking i.e., for consultants, assignees to interdepartmental working groups, the temporarily physically handicapped?
- A. Temporary parking will be available in keeping with the criteria or at commercial rates.
- 9. Are DOT employees in any way subsidizing the costs of parking for official vehicles?
- A. No. Spaces for official vehicles were arranged for under the building lease by GSA.
- 10. Will small cars have to pay the same fee as standard cars?
- A. Yes.

PUBLIC TRANSPORTATION

Most of the bus lines have informed us that they will be changing schedules and adding service when the Central Southwest Bus Terminal opens in November. A supply of current schedules from the four bus lines serving the Southwest Mall area was provided to Matomic Building employees prior to their move and arrangements are being made to have similar schedules available to Coast Guard personnel this week.

BUS TERMINAL STATISTICS

A great number of fans have commented on the statistics given for the service capacity of the new bus terminal. The error was not in our mathematics but in our typing. The maximum capacity should have read "165 buses and 10,000 (not 100,000) riders each hour."
