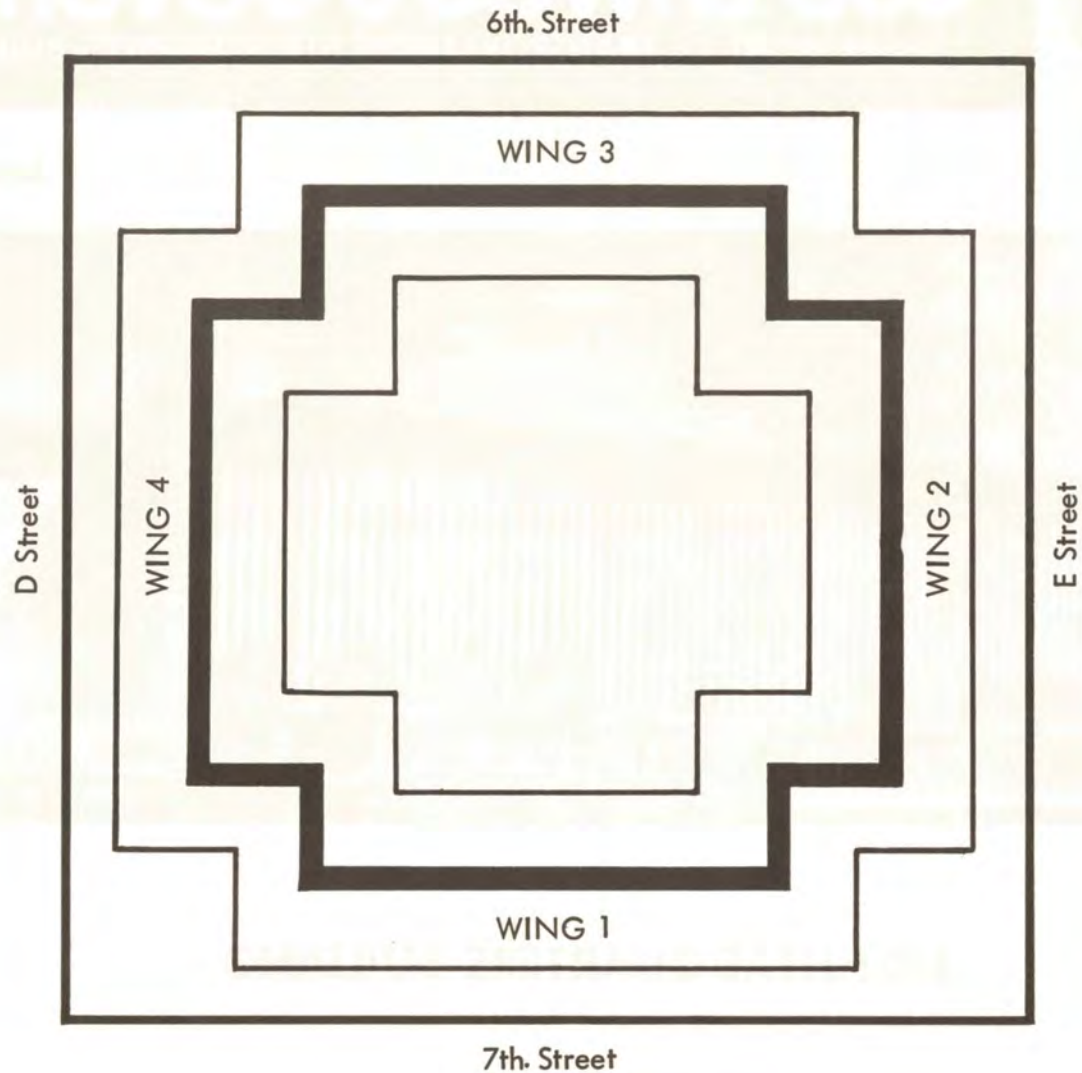


## DOT HEADQUARTERS BUILDING

This bulletin will be issued periodically during the consolidation of the Department of Transportation headquarters into two buildings -- 400 Seventh Street, S.W., and 800 Independence Avenue, S.W.



To assist employees who visit the Nassif Building to get an idea of the general building layout and room numbering system, the above sketch relates the wing locations to the street directions.

Room numbers indicate floor, wing, and room number. Thus, Room Number 2318 would be on the second floor, third wing, number 18. Numbers increase in the counter-clockwise direction with even numbers on the street side and odd numbers on the inner court side.

There are ten floors. Elevator banks are located at each corner of the building. There will be wing direction signs on each floor to assist in orientation.





#### New Express Bus Service Between Tyson's Corner and SW Washington

A new express bus, the Capital Flyer, is now operating between Tyson's Corner Shopping Center and Southwest Washington during rush hours and has cut significantly the travel time between those points. Operated by W.V. and M. lines under a grant from DOT, the Flyer leaves the shopping center every weekday morning at 6:30, 6:50, 7:20 and 7:50 and arrives at 4th and C Streets, S. W. approximately 45 minutes later, after stops at 19th and E Streets, N. W. and 14th and G Streets, N. W. Return trips in the evening leave from 4th and C Streets, S. W. at 4:15, 4:45, 5:15, and 5:35 p.m. The one-way fare is sixty cents.

The Tyson's Corner - S. W. run is one of three new express routes recently inaugurated under the sponsorship of the Washington Metropolitan Council of Governments. The others are Prince Georges Plaza, Maryland to S.W. and Korvette's, Rockville, Maryland to S.W. Detailed scheduled information for all of these services can be obtained by calling 223-3540.

#### Southwest Washington Bus Terminal

#### DOT Employee Parking

Although the centralized management of DOT employee parking at equalized rates has been postponed through February, parking is available in the Nassif Building at commercial rates (\$2 a day; \$35 a month).
