In view of the recent OMB proposals to restrict the Government's involvement in the provision of employee parking accommodations, nothing useful can be published until the OMB determination is received.

There is considerable street parking available in the immediate vicinity of the building and negotiations are in process to gain some spaces in the DOD parking lot. Parking should be no problem for the initial occupants of the building.
