NEW GREYHOUND BUS SERVICE: ANNAPOLIS--D.C.

Beginning February 1, 1972, Greyhound Lines is initiating an express "rush hour" bus service between Annapolis and D.C. Operating on weekdays, the new express bus will leave Annapolis at 6:50 a.m., arriving at Independence Avenue office buildings at 7:45 a.m. Return trip coaches leave 12th and Independence at 5:15, arriving in Annapolis at 6:10 p.m.

Greyhound is inaugurating the express service for the convenience of government employees working at the Bureau of Engraving and Printing, Department of Agriculture, Department of Defense, FAA, FBI, HEW, and other office buildings in the Southwest area.
