AB&W TRANSIT SERVICE TO THE SW AREA

The southwest bus terminal is now served by the following AB&W Transit Company routes via the 14th Street Bridge and Independence Avenue:

7M Lincolnia, Southern Towers

16M Columbia Pike

11M Alexandria

17M Kings Park, Braddock Road, Rt. 236

18M Springfield

Other commuters may take most AB&W buses that travel via the 14th Street Bridge and transfer to a "SW MALL" bus on 14th Street between "C" Street and Independence Avenue (alongside the Department of Agriculture building) at the following times:

GARAGE CLEAN-UP SERVICE

With the heavy usage of our parking facilities, it is inevitable that breakable items will be dropped on the floor or that similar minor accidents will occur. For instance, someone who had bought a pint bottle of Saniflush dropped it and it broke. It was then just left where it fell; it seeped through the floor and marred the paint of a car below.

CONVERSION OF "FREEDOM SHARES"

The Treasury has issued a regulation permitting exchanges of "Freedom Shares" for Series H savings bonds, an option that was available to holders of Series E bonds for over 10 years. Owners of the shares may exchange them, either alone or in combinations with Series E. bonds, for Series H bonds without regard to the \$5,000 annual limitation on Series H bond holdings.

Under the rules set out in the regulation, exchanges may be made either (1) with deferral of reporting for Federal income tax purposes of the accumulated interest on the securities exchanged to the year in which the Series H bonds are redeemed, disposed of or reach final maturity, whichever is earlier, or (2) without tax deferral.

The regulation, published in the Federal Register on December 15, 1971, became effective on January 1, 1972.

BICYCLE PARKING

The following item was submitted by the 'DOT Bicycle Commuters':

As the weather turns fair more DOT employees will no doubt try a bicycle for commuting to work. A bicycle is often faster than a bus for trips up to five miles and it is a good form of excercise. You are encouraged to pay the \$1.85 per month and park in the garage. Last year four bicycles were stolen and this year two bicycles are known to have been stolen. The locked chains were cut. Usually more bicycles are stolen after school is out. If you do park in the rack and ride your 10-speed favorite, consult the February 1972 issue of American Bicyclist in the library for advice on chains and March 1971 issue of Consumer Reports on locks. Regular commuters could leave a six foot section of case hardened chain of 3/8 or 7/16 inch diameter and lock on the rack.
