EMPLOYEE PARKING REGULATIONS

All DOT parking facilities permit holders are urged to review the printed "Rules of the Garage" issued to you recently with your new permits. For your own safety and that of your fellow employees, it is imperative that these rules be followed. To avoid accident, speed must be held to a minimum and headlights turned on when driving through any of the parking areas. The rules also specifically caution against leaving the small identification card in your car. That practice increases the possibility of theft not only of your own car but of others. You are reminded that the printed rules inform you that if the small card is in your unlocked car, the garage attendants are instructed to remove and forward it and the large permit to the Parking Management Office. The continued enjoyment of the parking privilege calls for responsible, considerate performance by the permit holder.

OCCUPATIONAL SAFETY CONFERENCE

The DOT Occupational Safety Management Conference was conducted in Washington, November 5 through 8. Field and Headquarters representatives of all elements of DOT attended. This conference highlighted departmental compliance with the Federal Occupational Safety and Health Act (OSHA) and the importance of OSHA as a responsibility of management at all levels. Speakers included the Honorable Peter J. Brennan, Secretary of Labor; Mr. John W. Barnum, Deputy Secretary of DOT; and Mr. William S. Heffelfinger, Assistant Secretary for Administration. Mr. William P. Davis, Deputy Assistant Secretary for Administration, presented the Secretary's award for the most improved safety management program to Mr. Harry A. Lindberg, the Acting Executive Director of the Federal Highway Administration.

NEW THRUST IN LABOR MANAGEMENT RELATIONS IN DOT

DOT is moving ahead with the development of new Labor Management Relations Seminars. The first seminar to be developed will be directed at Departmental managers giving selected managers an awareness necessary to manage LMR throughout the Department, and giving them a DOT perspective of the LMR program. Another seminar will be developed at a later date that will be especially designed for personnel management specialists. Participants will be selected managers with an on-line need to understand the stated The program will deal with such topics as current objectives. status of LMR in the Department, the nature of unions, the DOT manager's responsibilities in LMR, maintaining effective awareness of LMR, and developing a management team to administer LMR. pilot session will be conducted on December 11-12-13, 1974, at the Hilton Hotel in Annapolis, Maryland. Following this session, an assessment will be made of the effectiveness of the seminar and at that time its future implementation will be determined.
