### SPRING CLEANING TIME!

The DOT warehouse has initiated a program to purge all outdated, obsolete publications. The goal is to free valuable space in the warehouse and to make possible more efficient service on those publications still in demand. During the first few weeks of this program, 167 publications have been identified by the originating administration for either disposal or reduction of stock. As a result, 17,046 cubic feet of space has been cleared and over 15 tons of paper made available for recycling.
