# MR. W. T. COLEMAN, JR., NOMINATED AS NEW SECRETARY OF TRANSPORTATION

On Thursday, January 16, 1975, President Ford submitted to the Senate the nomination of Mr. William Thaddeus Coleman, Jr. to be the Secretary of Transportation. Mr. Coleman would replace Secretary Brinegar who submitted his resignation to be effective February 1, 1975. Mr. Coleman is fifty-four years of age and is a partner in the Philadelphia law firm of Dilworth, Paxson, Kalich, Levy and Coleman. He is no stranger to the transportation field having served as a Special Counsel for Transit Matters for the City of Philadelphia. He has also served as a Director on the Board of the Pan American World Airways, Inc. Prior to admission to the Pennsylvania Bar in 1947 he had received an AB degree from the University of Pennsylvania Summa Cum Laude, and an LLB degree from Harvard University, Magna Cum Laude. Mr. Coleman would be the fourth person to serve as the Secretary of Transportation.

### SECURITY REMINDER

Employees are again reminded to exercise a greater effort in protecting their personal property at all times particularly in their work environment. ## EXERCISE FACILITY

There have been two changes in the operation of the Coast Guard Exercise Facility. First, because of personnel shortages, the hours of operation of the Facility have been changed. The new hours are 8:00 a.m. to 5:30 p.m. Monday through Friday, excluding holidays. Tuesdays and Thursdays between the hours of 11:00 a.m. and 1:00 p.m. are reserved for females. Secondly, a medical form - which may be secured at the Exercise Facility - must be completed by all who use the facility. Also, all civilian employees, 40 years of age or older, must furnish a doctor's certificate stating that they have no known medical condition, and that exercising will not be deleterious to their health.
