GAMBLING

Section 101-19.305 of Title 41, Code of Federal Regulations prohibits "participating in games for money or other personal property, or the operation of gambling devices, the conduct of a lottery or a pool, or the selling or purchasing of numbers tickets in or on any property under the charge and control of GSA." All employees should be cognizant of this regulation and be guided accordingly.

OFFICE TEMPERATURES

The continuing energy conservation program has resulted in some imbalances in office temperatures in the headquarters buildings.

In the Nassif Building temperature control of the inner spaces-away from the windows--is effected by cooling the circulating air even during the heating season. The cooling system has been shut down to conserve energy, and as a result the circulating air has become uncomfortably warm in some places when the outside weather is unusually mild. It is not because the heating system is turned up too high. Only the second and tenth floors have heated air circulation.

The reduced heating levels in FOB-10A have caused cold spots because of difficulties in balancing the system. However, GSA is cooperating in efforts to level it off.

The Trans Point Building heating system is similar to the Nassif Building's with the same heat accumulation problem in some interior spaces. So far the problem does not appear to be as acute possibly because of the denser design of the building.
