PLANS FOR RESURFACING "D" STREET, S.W.

Within the next three weeks or so, D Street between 6th and 7th Streets will be closed for restoration. Slattery Company, the Metro Contractor, estimates that resurfacing, recurbing, replacement of sidewalks, planters, etc., will take approximately three weeks. The Headquarters Building garage traffic flow will undoubtedly suffer; however, to make it as easy as possible, the north (D Street) garage ramp will remain open to two-way traffic to and from 6th Street. Virginia Avenue will also be open to two-way traffic. Slattery has promised to have flagpersons at the intersections of Virginia Avenue and 6th and 7th Streets during rush hours.
