## NEED VERIFICATION OF YOUR EARNINGS OR OF EMPLOYMENT? WANT TO GET IT FASTER? HERE'S HOW YOU CAN HELP.

DOT employees who are seeking to establish charge accounts, obtain credit cards, apply for house mortgages, etc., are usually required to furnish information about their earnings and current and former places of employment. The credit or lending organizations nearly always contact the employer to verify the information furnished them by the applicant. Many employees are apparently indicating only that they are employed by the Department of Transportation-they are not indicating what administration they work for, or that they are employed by the Office of the Secretary. As a result delays are often encountered while a search is made to determine which personnel office has the records needed to answer the verification inquiry. If you apply for credit or for a loan, you can speed up the processing of your application and save the Department work too by being sure to indicate what part of DOT you work for.
