ATTENTION ALL DOT PARKING PERMIT HOLDERS

Monument Parking Company will begin its new contract year on November 1, 1976. They are required to mail new payment books to all permit holders prior to that date. This can be done only if the information on your parking permit application is current and correct. If you have moved and failed to notify Parking Management or for any other reason your correct address is not on file please stop by the Parking Management Office in room 2322 of the Nassif Building to bring your application up to date. DO NOT TELEPHONE. If it is inconvenient for you to come by and you know your address is incorrect in our files a "change application" will do just as well. All changes should be received no later than noon on Tuesday, September 28, 1976, so that envelopes can be addressed and mailed by the first of the following month. 1976/1977 COMBINED FEDERAL CAMPAIGN KICKOFF

This year's Combined Federal Campaign is now underway here in the National Capital Area. This is our once-a-year chance to contribute to so many needy agencies where we live and work. Two major changes positively affect this year's campaign. First, the Prince George's County Community Fund organization with its supported United Way Organizations has been welcomed back into the National Capital Area CFC/United Way fold. There will not be a separate campaign conducted by the Prince George's Community Fund such as there was last year. This positive movement should eliminate any uncertainties for our employees from the Prince George's County Area. Second, for the first time, reciprocal agreements have been reached with the Combined Federal Campaigns of several neighboring Maryland counties, so that employees working in the National Capital Area can designate their contribution to the CFC's conducted in Anne Arundel, Baltimore, Calvert, Carroll, Charles, Frederick, Hartford, Howard, and St. Mary's counties. In the past, we could only designate contributions to those voluntary service organizations listed with the CFC of the National Capital Area. If any DOT employee wishes to designate their contribution to any of the above mentioned counties they may do so in the same manner as is presently done for other designations, by writing in the designation on the rear of their pledge card. Designated contributions to those counties will be credited to the operating element campaign and the DOT totals, but will be forwarded to the specified campaign in accordance with the contributor's wishes. This change may be important to many DOT employees whose residences are outside the National Capital Area boundaries.

Three showings of this year's CFC 15-minute film titled "A Double Life" have been arranged for DOT employees at our three building locations in accordance with the following schedules:
