



## NATIONAL HISPANIC HERITAGE WEEK

## OFFICE THEFT SEMINAR

On September 13, 14, and 15, 1977, the OST Office of Investigations and Security, in cooperation with the Metropolitan Police Department, is sponsoring a seminar to help familiarize DOT personnel with office theft problems and preventive measures that can be taken.

Each session will last one hour and is given by specially trained officers of the Metropolitan Police Department.

Two sessions per day are scheduled for each building as follows:

FOB-10A - September 13, at 10:00 a.m., and 2:00 p.m., in the third floor auditorium.

DOT Hqs. Bldg. - September 14, at 10:00 a.m. and 2:00 p.m., in room 2232.

## FIRE HAZARD

A growing number of reports have been received concerning electric coffee pots left plugged in overnight in DOT buildings. The use of coffee pots is illegal in Government buildings unless wired in accordance with GSA's PBSP 5800.18A, Chapter 20-14. Coffee pots left on after duty hours, even though they are Underwriters Laboratory approved, are safety hazards. They also waste energy. Henceforth, coffee pots found left on after hours will be subject to confiscation. Please be careful.
