"I do not drink alcoholic beverages, nor have I learned how to drive an automobile. I have selected this topic because I can relate to the subject matter.

"My beloved father, who has now been deceased for four years, was a heavy drinker of alcoholic beverages. He also drove a car, and held down various jobs as a truck driver. I loved him very much and shall cherish the many golden and tender moments we shared as father and daughter.

"There were many times when I worshipped him as I'd sit thrilled and enchanted while listening as he talked of his childhood days growing up in the streets of Philadelphia; working in the coal mines in West Virginia, and serving in the United States Army during the latter part of World War II. He was a very special person in my life, and I felt no other fathers could compare to my gentle and

understanding father. As a little girl growing up, he was always there ready and willing to comfort me, whether it was from a scraped knee, difficulty in understanding my school work, a frightened little girl awakened during the night after having a nightmare, or a bout with tonsillitis. Those were the times which shall live on in my memory.

"Yet, there were times when I viewed him with pain and frustration, especially on the Sunday afternoons or late evenings as we went for long rides along the countryside to escape the sweltering heat or summers in the city. My father would keep several cans of beer (six packs as they are often called) and quite often a bottle of wine, in the cooler in the trunk of his car. The further we rode, the more frequently he stopped to get a beer or pour himself some wine into a small plastic cup. As his drinking increased, the needle on the speedometer pointed to a greater speed.

"Often I sat up front between my mother and father. I noticed the tension within my mother as she would plead with my father, 'Slow down, please slow down, you're driving too fast.' He would angrily reply, 'Oh stop whining, I know what I am doing'! The outcome of those rides most of the time resulted in bitter words spoken between my parents.

"As I sat amidst the bickering and arguing, I would look from one parent to another. I felt a helplessness that cannot be defined. I loved them both dearly and it was quite painful to see them so angry with one another. So I would let my thoughts drift to the music playing on the radio, hoping it would drown out the noise and confusion my parents were engaged in. Occasionally, my mother would turn down the volume on the radio and in between periodic silences, all that was heard was the steady drone of the car's motor as we sped down the

highway. "On one special occasion in celebration of my birthday, my parents took me to the Red Bard Restaurant. My father had been drinking as usual. On our way home that night, his speeding was so excessive that he actually turned a corner on two wheels. Mama became so frightened that she began to cry and started screaming, 'You're going to kill us, please for God's sake slow down.' I began to cry also, mainly because my mother was crying. My father slowed down after seeing I had become upset.

"One evening my father was later than usual coming home from work. That particular evening I was looking forward to his coming home because he had promised to take me to McDonald's. He would always take me to McDonald's whenever I did not like what we were having for dinner. When

Commander Scheib Heads EMS Division

Commander Thomas Scheib, United States Coast Guard, has been appointed Chief, Emergency Medical Services (EMS) Division, National Highway Traffic Safety Administration (NHTSA)

For thousands of traffic accident victims, medical treatment provided by an EMS team is the critical link between an accident site and a major medical facility.

Scheib will put top priority on the development of national quidelines to promote efficient and effective state-operated EMS programs and systems. He will also serve as coordinator for the states on major EMS concerns, including vehicles and medical equipment, communication systems, administrative innovations and training of technicians. He will report to George L. Reagle, NHTSA Associate Administrator for Traffic Safety Programs.

Scheib joined the Department of Transportation as executive secretary of the Military Assistance to Safety and Traffic Programs, an interagency program providing military aeromedical resources to transport civilian emergency medical patients. For two years prior to that he served as evaluation coordinator for the Office of Emergency Medical Services, Department of Health and Human Services.

A native of Ohio, Commander Scheib holds a bachelor's degree in psychology from Denison University, Granville, Ohio, and a Master of Science Degree in psychobiology from the University of Michigan, Ann Arbor, Michigan.

In addition, he has had extensive post graduate training in biostatistics and industrial hygiene.

In 1970, Scheib was commissioned as an officer in the United States Public Health Service, and he was assigned to the U.S. Coast Guard in 1981.

Procurement Reforms - Now!

In a memorandum from Administrator Steed to AAs, SODs, and ODs, she wrote:

"Recently, the Office of the Secretary directed the immediate implementation of procurement reforms....

"Effective immediately, all procurement requests must include a 'statement of essential need' justifying the requested procurement. This statement should be a brief, concise paragraph or two that details why the procurement is necessary for the accomplishment of NHTSA's mission, and the impact if the procurement is not made.

"The statement should not be merely a repeat of the procurement, but rather a statement as to why the procurement is needed and not simply a 'nice to have' item or project.

"The statement may be included on the first page of the procurement request, or included as a separate attachment to the request. For procurement requests up to \$100,000, the statement may be approved by the requesting Associate or Acting Associate Administrator. For procurements estimated to exceed \$100,000, the statement will be prepared for my signature.

"For procurement exceeding \$100,000 or modifications to existing contracts which will cause the total expenditure to exceed \$100,000, the procurement must be approved by the Office of

the Secretary prior to issuing a solicitation. A new 'procurement Prenotification Form' has been developed for this purpose.

"The procurement request cover sheet with appropriate approvals, the statement of essential need, and the Commerce Business Daily synopsis must be attached to the form when it is forwarded to the Office of the Secretary.

"All prenotification forms will be transmitted to OST by a memorandum signed by me.

"As no official procurement action may be taken until the form is returned approved, the procurement leadtime could be significantly increased.

"The Office of Contracts and Procurement will be responsible for the processing of the prenotification forms through channels and will assist the program offices in completing the form."

DOT Employees Asked to Conserve Energy

In a memorandum to all DOT employees, the Assistant Secretary for Administration, Robert L. Fairman states that: Each year the Federal Government spends about \$4 billion for energy in buildings.

Since 1973 there has been a concentrated effort to reduce energy consumption not only to help reduce the cost of Government, but also to enable us to better manage this precious resource. Although initial conservation efforts in buildings produced good results it has been noticed that we are "sliding back" toward increased consumption.

Past experience has shown that significant savings can be achieved with no dollar investment if employees develop good energy conservation habits... "To assure the success of this program I encourage you to observe the following five energy conservation practices:

- " 1) TURN OUT THE LIGHTS WHEN YOU LEAVE THE ROOM; EVEN FOR A FEW MINUTES AND ESPECIALLY AT THE CLOSE OF BUSINESS.
- " 2) TURN OFF OFFICE EQUIPMENT OR PLACE IT IN A STANDBY MODE, AS APPROPRIATE, WHEN NO LONGER NEEDED.
- " 3) KEEP VENTILATION SYSTEMS FREE OF OBSTRUCTIONS...THAT BLOCK OR RESTRICT THE FLOW OF AIR.

" 4) KEEP DOORS, WINDOWS, OR OTHER ACCESSES CLOSED WHEN THE HEATING AND COOLING SYSTEMS ARE OPERATING.

" 5) KEEP BLINDS AND DRAPES CLOSED WHEN THE AIR-CONDITIONER IS OPERATING."
