NOTICES AND AMENDMENTS PUBLISHED DURING MARCH AND APRIL

- HM-106; Notice No. 73-2 (38 F.R. 7470 - 3/22/73). This notice covers miscellaneous proposals A through M. The comment period has been extended to July 31, 1973 (38 F.R. 10960 - 5/3/73).
- HM-22; Notice No. 73-3 (38 F.R. 10014 - 4/23/73). Matter Incorporated by Reference. This notice proposes to update the reference to the addenda to sections VIII and IX of the ASME Code. Comment period closes June 12, 1973.
- HM-102 Request for Advice Re: Need for Environmental Impact Statement (38 F.R. 10118 - 4/24/73).
- HM-103 Request for Advice Re: Need for Environmental Impact Statement (38 F.R. 10117 - 4/24/73).
- HM-107; Amendment Nos. 173-71, 177-25 (38 F.R. 7561 - 3/23/73). This amendment permits shipment of hazardous materials sold by the Department of Defense in packagings of equal or greater strength and efficiency than those specified for hazardous materials in 49 CFR Parts 170-189. Effective June 30, 1973.
- HM-96; Amendment Nos. 171-18, 173-72 (38 F.R. 8161 - 3/29/73). This amendment provides that incident reports involving etiologic agents may be reported to either the Department or to the Center for Disease Control, HEW in Atlanta, Ga. Also, cultures of etiologic agents of 50 milliliters or less total quantity in one outside package are exempt from 49 CFR Parts 170-189. Effective June 30, 1973.


