NOTICES AND AMENDMENTS PUBLISHED DURING MARCH

HM-115; Notice No. 74-3 (39 F.R. 7950 - 3/1/74).
This notice of proposed rule making proposes to provide for the transportation of cryogenic liquids in certain packagings and to authorize a new DOT specification MC 338 for a cargo tank constructed for use in transporting certain cryogenic liquids. Comment period closes June 18, 1974.

The closing date for filing comments in the following dockets falls on May 28, 1974:

- HM-90; 74-2 Bottom Outlets on Flammable Compressed Gas Tank Cars
- HM-103; 73-10 Hazard Information System and Miscellaneous Proposals
- HM-112; 73-9 Consolidation of Hazardous Materials Regulations and Miscellaneous Proposals

COMPANY PENALIZED FOR IMPROPER ACID SHIPMENT

Georgia-Pacific Corporation pleaded guilty to 30 of the 73 counts in an indictment that charged the company with shipping 93 per cent sulfuric acid in railroad cars not qualified for that purpose.

The indictment charged violation of the Federal Hazardous Materials Act. The tank cars, normally employed for caustic soda, are not subject to the same testing requirements as those for sulfuric acid, and have some exposed piping that makes them more vulnerable in a derailment.

On February 22, the U.S. District Court in Seattle fined the Company \$15,000.

AEC PUBLICATION AVAILABLE

The U.S. Atomic Energy Commission has updated its "Directory of Packagings for Transportation of Radioactive Materials," WASH-1279. The directory was prepared by the AEC's Transportation Branch in the Division of Waste Management and Transportation. Its purpose is to offer shippers a chance to avail themselves of existing packagings, rather than go through expensive design, approval, and construction of new packagings. The directory is indexed by AEC approval number (old DOT Special Permit number) shield thickness, cavity size, and common name.

The directory is for sale at the Government Printing Office, Superintendent of Documents, Washington, D. C. 20402, at a cost of \$2.60 per copy.

SEE SECTIONS 171.15 AND 171.16 OF TITLE 49
FOR REPORTING OF HAZARDOUS MATERIALS INCIDENTS

During the past 3 years, only 725 carriers have submitted hazardous materials incidents reports. Since there are several thousand carriers who may be transporting hazardous materials, a better understanding of the reporting requirements must become more widespread.

A written report, on DOT Form F5800.1, is required when there is any unintentional release of hazardous materials during transportation. Where death, injury, or property damage exceeding \$50,000 is involved, an immediate report (by telephone) is also required, but regardless of that immediate report, the written report on Form F5800.1 must be submitted if there is any unintentional release of hazardous materials.

The requirements covering reporting of Hazardous Materials Incidents are set forth in sections 171.15 and 171.16 of the Hazardous Materials Regulations (CFR Title 49, Parts 100-199).

REQUEST FOR DATA CONCERNING
CLASSIFICATION AND TRANSPORTATION OF PRODUCTS

Information data received by this Office in response to our request in the OHM Newsletter of February 1973 has been most helpful. We would now appreciate receiving any tabulations of data or documentation concerning classification and transportation of products, whether regulated or unregulated, as determined by tests specified by the amended definitions in sections 173.115 and 173.240 of the Hazardous Materials Regulations.

A FINE OF \$400.00 IMPOSED
FOR VIOLATION OF HAZARDOUS MATERIALS REGULATIONS

On October 26, 1973, Jimmy Lewis Cooper, driver for Baggett Transportation Company of Birmingham, Alabama, was fined \$400.00 for violation of the Hazardous Materials Regulations.

Appearing before U.S. District Judge R. Macey Taylor, defendant entered a guilty plea to a 4-count Information charging failing to attend at all times a vehicle containing Class A Explosives in violation of 49 CFR 397.5; parking a vehicle containing Class A Explosives within 5 feet of the traveled portion of a street or highway in violation of 49 CFR 397.7 (a)(1); parking a vehicle containing Class A Explosives within 300 feet of dwellings, buildings, and places where people congregate, work, or assemble in violation of 49 CFR 397.7(a)(3), and operating a vehicle containing Class A Explosives over a route through or near heavily populated areas, places where crowds assemble and over narrow streets in violation of 49 CFR 397.9(a).

Judge Taylor ordered the fine to be paid.

A FINE OF \$6500.00 IMPOSED
FOR VIOLATION OF HAZARDOUS MATERIALS REGULATIONS

On March 6, 1974, Ireco Chemicals Company of West Jordan, Utah was fined \$6500.00 for violation of the Motor Carrier Safety and Hazardous Materials Regulations.

Ireco Chemicals Company appeared with counsel before Chief Judge W. W. Ritter and entered a plea of guilty to an Information charging failing to maintain driver qualification file including medical examiner's certificate, in violation of 49 CFR 391.51(b)(1); failing to maintain driver qualification file including driver's road test certificate, in violation of 49 CFR 391.51(c)(4); failing to maintain driver qualification file including written test certification, in violation of 49 CFR 391.51(c)(5); failing to require driver to prepare daily vehicle condition report, in violation of 49 CFR 396.7, and failing to require driver to have in his possession a shipping paper properly describing shipment of hazardous materials, in violation of 49 CFR 177.817(c).
