NOTICES AND AMENDMENTS PUBLISHED DURING APRIL

- HM-22; Notice No. 74-4 (39 F.R. 12034 - 4/2/74). This Notice of Proposed Rule Making proposes to update the reference to The Chlorine Institute's standards for valves on chlorine tank motor vehicles and change the reference in § 178.337-2 from ASTM A-300 to ASTM A-20. Comment period closes June 28, 1974.
- HM-116; Notice No. 74-5 (39 F.R. 12261 - 4/4/74). This Notice of Proposed Rule Making proposes to permit the USAEC to examine, classify, and approve for its own activities new explosives as being safe for transportation; to restructure the current regulations in § 173.86 for clarification; and provide a shipping name for samples of explosives shipped under § 173.86a. Comment period closes July 9, 1974.
- HM-22; Notice No. 74-6 (39 F.R. 14357 - 4/23/74). This Notice of Proposed Rule Making proposes to update the reference to the addenda to sections VIII (Division I) and IX of the American Society of Mechanical Engineers Boiler and Pressure Vessel Code. Comment period closes July 2, 1974.
- HM-112; Notice No. 74-7 (39 F.R. 14519 - 4/24/74). This Notice of Proposed Rule Making withdraws the listing of organic peroxides proposed in HM-112;73-9, and lists the organic peroxides to complete the Board's intent on handling of these materials until the United Nation's work is completed. Comment period closes August 31, 1974.

Notices and Amendments Published During April Cont.

HM-104; Amendment Nos. 171-24, 172-24, 173-79, 174-21, 178-32 (39 F.R. 12749 - 4/8/74). These amendments cover miscellaneous changes in 5 Parts of the Hazardous Materials Regulations. The effective date is September 30, 1974 except for the regulations covering "Ammonium nitrate (no organic coating)" and "Ammonium nitrate fertilizer" as they relate to shipping papers and markings on packagings. These materials which were formerly described in accordance with section 172.5 as "Ammonium nitrate fertilizer, containing 90 per cent or more ammonium nitrate with no organic coating" may continue to be so described on shipping papers and so marked on packagings until June 30, 1975, with immediate compliance authorized.

HM-105; Amendment Nos. 172-25, 173-80, 179-12 (39 F.R. 15034 - 4/30/74). These amendments update and expand tank car utilization for hazardous materials as prescribed in Part 173. The effective date is September 30, 1974, with immediate compliance authorized.

Notice of Special Permits issued or denied during April 1974 (39 F.R. - 5/10/74).

A FINE OF \$250.00 IMPOSED FOR
VIOLATION OF HAZARDOUS MATERIALS REGULATIONS

On December 6, 1973, Billings Transfer Corp., Inc., Lexington, North Carolina, defendant, a common carrier by motor vehicle engaged in the transportation of furniture and general commodities in interstate commerce, was fined \$250.00 for violation of the Hazardous Materials Regulations.

Appearing before U. S. District Judge Matthew Ott, defendant entered a guilty plea to a 1-Count Information charging failure to placard a motor vehicle transporting flammable liquids in violation of 49 CFR 177.823.

A FINE OF \$1,500.00 IMPOSED FOR
VIOLATION OF HAZARDOUS MATERIALS REGULATIONS

On February 28, 1974, Southern Forwarding Company, Memphis, Tennessee, defendant, a common carrier by motor vehicle engaged in the transportation of general commodities in interstate commerce, was fined \$1,500.00 for violations of the Hazardous Materials Regulations.

Appearing before U. S. District Judge Aaron Brown, Jr., defendant, entered a plea of guilty to a 15-Count Information charging failure to require drivers to have in their possession a shipping paper properly describing shipment of hazardous materials in violation of 49 CFR 177.817.

HAZARDOUS MATERIALS SEMINAR - CLEVELAND


The Office of Hazardous Materials will sponsor a 2-day seminar on July 24 and 25, 1974, in Cleveland, Ohio. This seminar is designed to assist motor, rail, water, and air carriers, including freight forwarders, shippers, container manufacturers, packaging, firefighting and law enforcement personnel, Federal, state and local agencies and other interested personnel to understand the DOT Hazardous Materials Regulations.

The first day (July 24, 1974) will be a discussion of the DOT Hazardous Materials Regulations as they apply to all modes of transportation.

The program for the second day (July 25, 1974) is designed to provide a better understanding of the existing DOT packaging requirements for hazardous materials. This will include the proper selection of authorized containers, packing requirements, filling and closing of containers as well as the required marking and labeling requirements. It will also include techniques for visual inspection of the completed packages to determine compliance with the Hazardous Materials Regulations, and applicable carrier tariffs.
