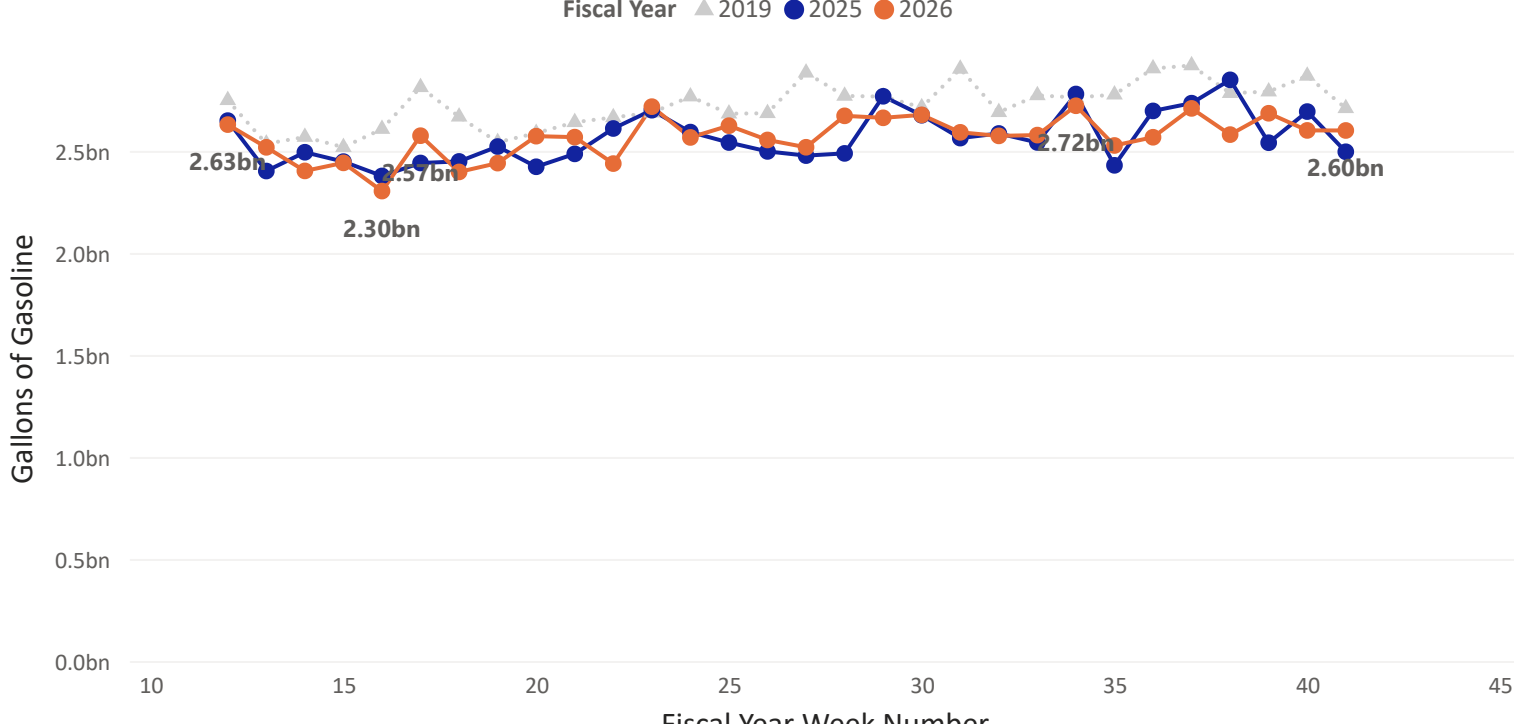

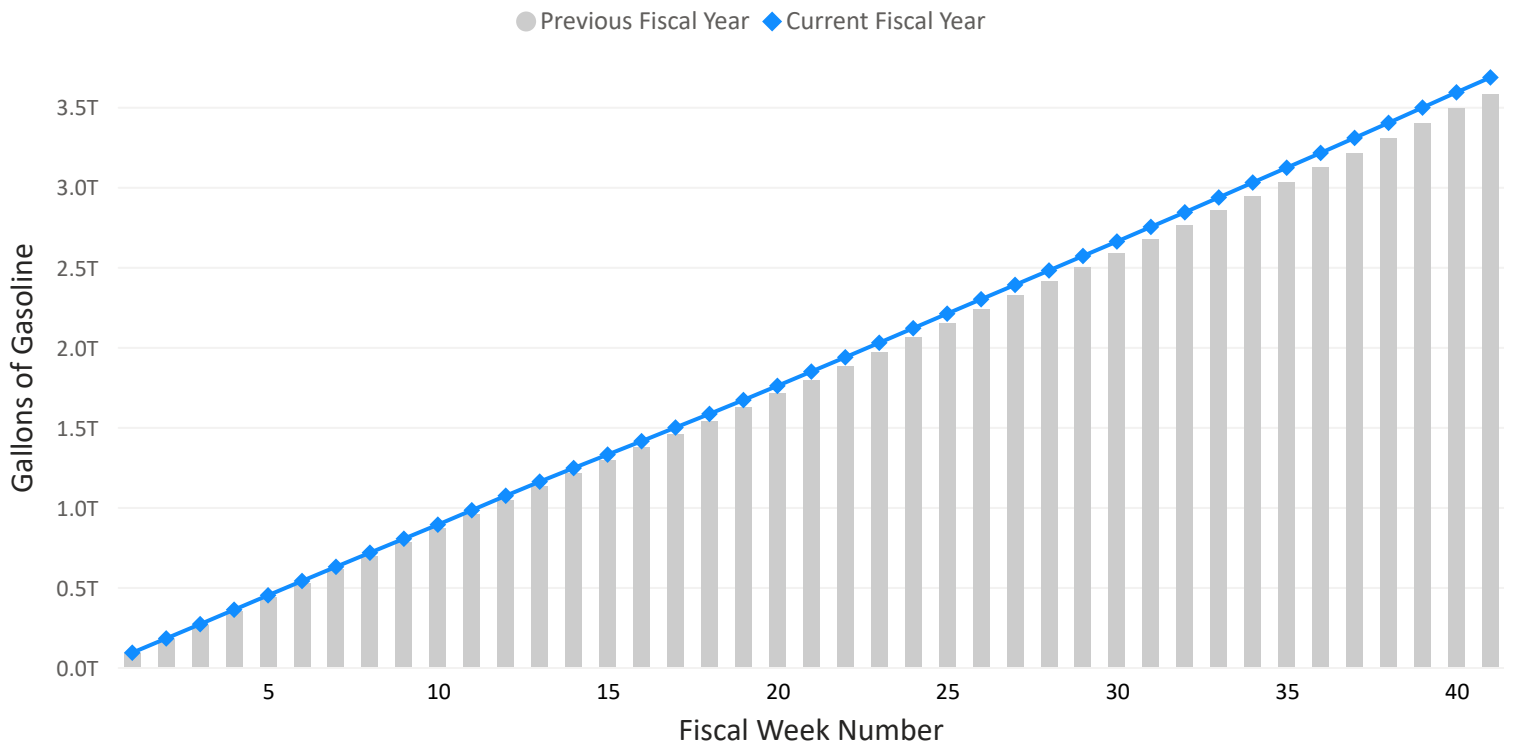
Gasoline product supplied totaled 2.6 billion gallons in week 41. This is a decrease of 0.01% from the previous week.

Weekly Gasoline Product Supplied



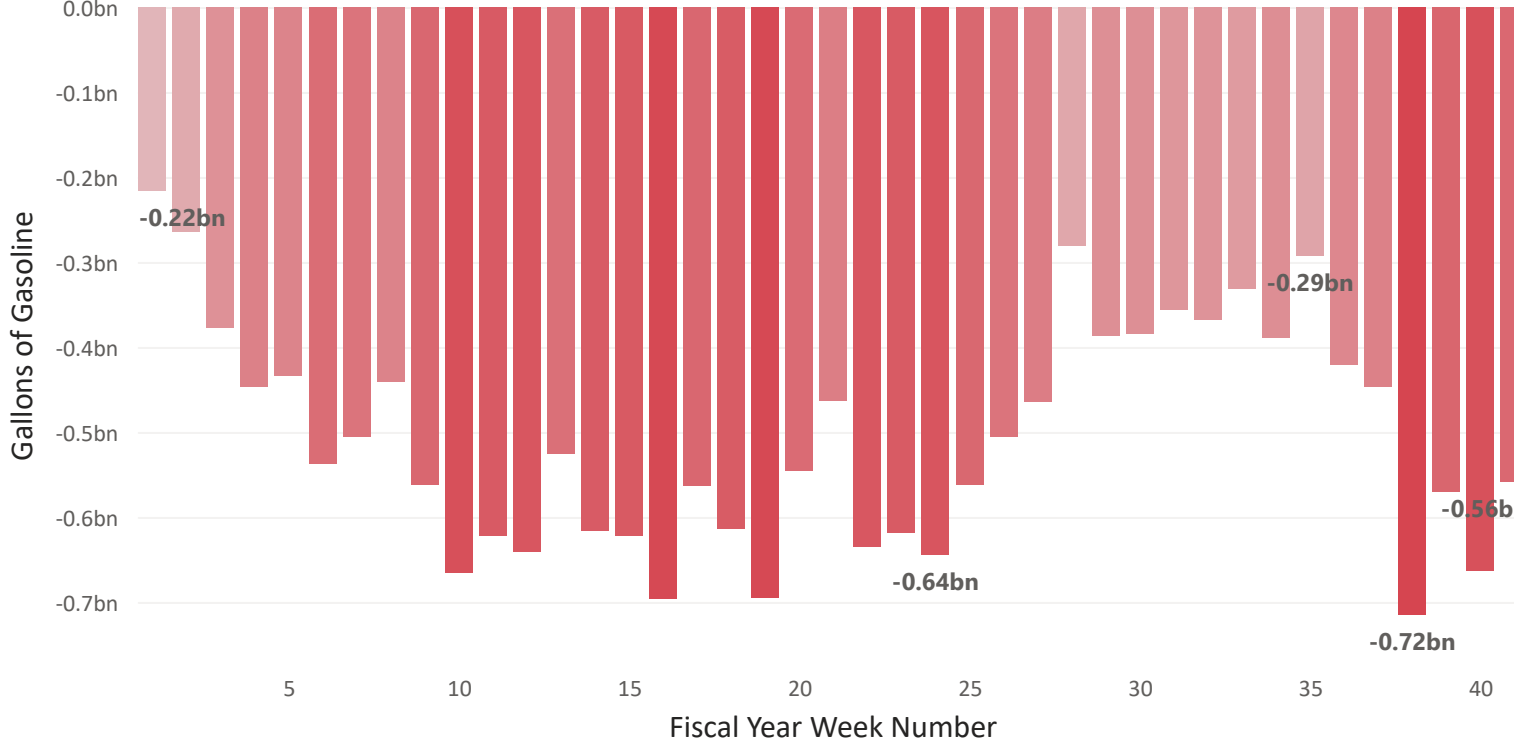
Gasoline product supplied compared to the same week in FY 2025 increased by 4.18% and decreased by 4.02% for the same week in FY 2019.
